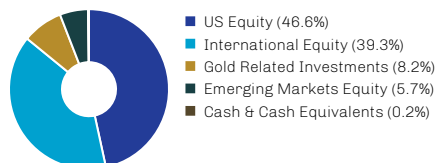

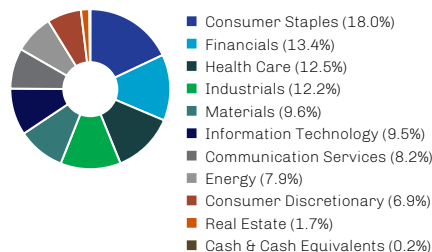

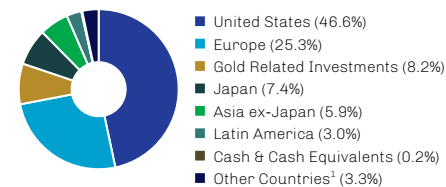
## Allocation by Asset Class
